Screenco Manufacturing Ltd. Warranty

The Warranty

- 1. Screenco Group Inc., its subsidiaries and related corporations (the "Manufacturer" or "us") warrants that its fabricated screen products (the "screens" or "products") will be free of manufacturing defects or material flaws for a period of ninety (90) days from the date the products are shipped to the original purchaser (the "Warranty Period"). Manufacturing defects and material flaws are defined as defects that render the screen unusable for its designed purpose. The purchaser shall promptly notify the Manufacturer should any manufacturing defects or material flaws become apparent within the Warranty Period. Claims under this warranty must be made within the Warranty Period. All visible defects or flaws must be reported immediately upon installation. Failure to report defects or flaws to us as specified herein, void this warranty.
- 2. If the Manufacturer determines that a manufacturing defect or material flaw exists that is covered by this warranty, the Manufacturer will, at its sole option and discretion, repair or replace the product/component(s) at the Manufacturer's expense, and ship the repaired/replaced product/component(s) to the original purchaser in the same condition as the product was originally sold, subject to the Manufacturer's right to substitute a similar product when the product originally sold has been discontinued or modified. If the Manufacturer is unable to provide replacement, and repair is not practical, then the Manufacturer may elect, at its sole discretion, to refund the purchase price paid directly to us for the applicable product. Refund is not a benefit covered by this warranty and is a fully discretional option included for the benefit of the Manufacturer if they elect to implement it. The remedies outlined in this section will be the purchaser's sole and exclusive remedies for a breach of the warranty.
- 3. The warranty on any repaired or replacement screen will extend for the balance of the original Warranty Period and will not create a new Warranty Period.
- 4. The Manufacturer shall have no responsibility for any damages or injuries arising or resulting from the failure of the screens, improper installation of the screens, or any other unintended modification or use. <u>Use caution when handling, installing and/or removing screens. Torn screen mesh, and scratched or bent screen frames are not covered by this warranty</u>. This warranty is not a promise of future performance nor a policy of insurance. Shipping and handling is not included in this warranty.
- 5. THE MANUFACTURER WILL NOT BE LIABLE FOR ANY DIRECT OR INDIRECT COST, EXPENSE, LOSS OR DAMAGE TO PERSON OR PROPERTY (EXCEPT AS REQUIRED BY LAW), OR ANY CONSEQUENTIAL LOSSES OF ANY KIND, INCLUDING BUT NOT LIMITED TO LOSS OF PROFIT, HOWEVER ARISING, EVEN IF THE MANUFACTURER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND EVEN IF SAME WERE REASONABLY FORESEEABLE.

- 6. All of the Manufacturer's products are sold 'as is' and as such the Manufacturer disclaims any and all implied warranties. The entire risk as to the quality and performance of the goods is with the original purchaser. EXCEPT AS EXPRESSLY SET OUT HEREIN, TO THE FULLEST EXTENT PERMITTED BY LAW, THE MANUFACTURER MAKES NO GUARANTEES, REPRESENTATIONS OR WARRANTIES, WHETHER EXPRESS OR IMPLIED, IN FACT OR IN LAW, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABLE QUALITY, OR FITNESS FOR A PARTICULAR PURPOSE OR USE. It is the original purchaser's sole responsibility for determining whether a screen purchased from us is suitable for an end user's needs or application.
- **7.** Failure by the original purchaser or end user to follow the installation and maintenance instructions available from the Manufacturer voids this warranty.
- **8.** This warranty sets forth our maximum liability for our screen products. No one is authorized to modify or expand this warranty.

Exclusions from Coverage

- **9.** This warranty does not cover the screen fabric used in our products. The screen fabric is covered by warranty provided by the screen fabric supplier. For a copy of the screen fabric supplier warranty, please contact our Customer Service Department at info@screenco.ca.
- **10.** Notwithstanding anything in this warranty document to the contrary, the warranty does not cover damage relating to:
 - **a.** Insects penetrating around the insect screen frame;
 - **b.** No-see-um or smaller insects penetrating any screening fabric;
 - **c.** Natural weathering:
 - **d.** Acts of God and damage because of environmental conditions, and events beyond the control of the Manufacturer (for example, fire, hurricane, tornadoes, storms, strong winds, natural disasters etc.);
 - **e.** Building settling, structural failures of walls or foundations:
 - **f.** Damage to the screen or its components caused by deliberate or accidental misuse, abuse or neglect;
 - g. Disassembly or modification of the screen or its components;
 - **h.** Information supplied by the purchaser to the Manufacturer that is relied upon to manufacture the products:
 - i. Improper screen assembly, installation and/or adjustment;
 - Damage caused by humans or animals running or walking into the screen;
 - **k.** Improper storage:
 - **I.** Improper handling;
 - m. Failure to properly care for and maintain the products;
 - n. Expansion and contraction of window or door frame in excess of 1/16";
 - **o.** Tears in the screening fabric;

- **p.** Dents or scratches in the screen frame:
- **q.** Damage caused to the screen or components by inadequate maintenance;
- **r.** General deterioration in appearance or performance that occurs because of normal operation and normal wear and tear;
- **s.** Progressive deterioration of finishes and materials due to exposure to sun, rain, abrasion, heat and/or cold.

THE MANUFACTURER WILL NOT BE LIABLE FOR ANY ORAL STATEMENT OR OTHER WRITTEN STATEMENT ABOUT ANY OF THE MANUFACTURER'S PRODUCTS, WHETHER SUCH STATEMENTS ARE MADE BY AN AGENT OR EMPLOYEE OF THE MANUFACTURER OR BY ANY OTHER PERSON. THE MANUFACTURER DOES NOT AUTHORIZE ITS REPRESENTATIVES, DISTRIBUTORS, CONTRACTORS OR DEALERS TO MAKE ANY CHANGES OR MODIFICATIONS TO THIS WARRANTY. EXCEPT WHERE PROHIBITED BY LAW, THE

- 3. Binding arbitration: every claim, controversy or dispute of any kind whatsoever (an "action") between you and the Manufacturer (including any of its employees and agents) relating to or arising out of the screens or this warranty shall be resolved by final and binding arbitration, regardless of whether the action sounds in warranty, contract, statute or any other legal or equitable theory. You and the Manufacturer agree that any action will be arbitrated on an individual basis and that no claim(s) will be consolidated or aggregated with the claim(s) of any other persons by class action, class arbitration, in a representative capacity or otherwise. To arbitrate an action against the Manufacturer, you must initiate the arbitration, for U.S. claims, in accordance with the federal arbitration act, to be conducted by a single arbitrator in accordance with the rules of the American Arbitration Association, and for Canadian claims, in accordance with the Arbitration Act, Ontario, as may be amended, and you must commence the arbitration and provide written notice to the Manufacturer by certified mail at the applicable address noted above, within the applicable time period.
- 4. No action or breach of this warranty or any other action against the Manufacturer relating to or arising out of the screens, their purchase or this transaction shall be brought later than one (1) year after any cause of action has arisen or accrued. In jurisdictions where statutory claims or implied warranties and conditions cannot be excluded, all such statutory claims, implied warranties and conditions and all rights to bring actions for breach thereof expire after one (1) year, or such longer period of time if mandated by applicable laws, after the purchase of the screen product. Some jurisdictions do not allow limitations on how long an implied warranty or condition lasts, so the above limitation may not apply to you in those jurisdictions.
- **5.** This warranty shall be interpreted, construed, and applied under the laws of the Province of Ontario, in the jurisdiction of Toronto, Canada.

This Limited Warranty applies to Manufacturer's screens sold on or after January 1, 2025 and supersedes all previously published warranties.
